

**\*Terms & Conditions: One FREE Mini Consultation for Varicose Veins or Hernia, at Three Shires Hospital, Part of Circle Health Group.**

When we use the words “we”, “our” or “us” in these Terms we mean Circle Health Group Limited, a limited company incorporated and registered in England and Wales with company number 02164270 whose registered office is at 1st Floor, 30 Cannon Street, London, EC4M 6XH. You can find everything you need to know about us, and our services on our website.

When booking your FREE 15-minute consultation (the “Consultation”) at Three Shires Hospital, you agree to the following terms and conditions:

### **1. Consultation Details**

1.1. The Consultation will last up to 15 minutes.

1.2. The Consultation does not include tests or scans. No formal diagnosis will be provided. Mr Rob Hicks will offer general advice based on your medical history and symptoms discussed during the Consultation.

1.3. There are 10 FREE 15-minute Consultations available with Mr Rob Hicks ONLY.

### **2. Restrictions and Requirements**

2.1. You must be over the age of 18.

2.2. The Consultation is only valid at Three Shires Hospital, in Northampton.

2.3. The Consultation is only valid on 3<sup>rd</sup> February, during the hours of 5:30 pm – 8:00 pm.

2.4. One Consultation per person is permitted and is subject to availability.

2.5. If you cancel a booked consultation for any reason with less than 48 hours' notice or do not attend your booking, you will not be eligible to book another free consultation.

2.6. Employees of Circle Health Group Limited and their families are ineligible for a free consultation.

### **3. Personal Information**

3.1. Your information will be securely stored and utilised exclusively for internal purposes.

3.2. To secure your Consultation, you must provide a minimum data set, including your name, address, GP provider, and whether you have been a patient with us before, for us to book this Consultation into our system. This information will be stored solely for the purpose of this event.

5.6. If there is any conflict or inconsistency between any marketing materials and these Terms, these Terms will take precedence.

5.7. We may transfer our rights and obligations under these Terms to another organisation, and we will always notify you in writing if this happens, but this will not affect your rights or our obligations under these Terms.
